MAPEI ACTIVE SIL-2

Anti-stripping agent for bitumen

DESCRIPTION

Mapei Active Sil-2 is a high-performance silane-based liquid additive developed to improve the chemical-physical compatibility between bitumen and aggregates, particularly useful when using acidic aggregates that are poorly compatible with the bitumen or in geographical areas exposed to heavy rainfall or high concentrations of moisture. The use of Mapei Active Sil-2 helps to extend the life of the road surface by reducing leaching of bitumen as a result of weathering and reducing chipping in the wearing course.

MAIN AREA OF APPLICATION

The use of **Mapei Active Sil-2** is recommended with all types of bitumen, both polymer-modified (elastomeric, thermoplastic) and unmodified; with all types of asphalt mixtures, both conventional (dense) and porous, to extend their durability, significantly reduce regular maintenance. In certain cases (depending on the nature of the bitumen), the additive can improve the workability and compactability of asphalt mixtures.

ADVANTAGES

The use of Mapei Active Sil-2 allows:

- improving the degree of coverage and the affinity of bitumen to aggregates and increasing the resistance of bitumen to washing away by water (EN 12697-11; EN 12697-12; EN 12697-17; ASTM D 3625; ASTM D 4867; AASHTO T 283; AASHTO T 324);
- increase pavement durability and reduce maintenance;
- increase in the workability and compactability of the asphalt mixture (depending on the nature of the bitumen):
- stability of the properties of the hot asphalt mixture during storage in the silo.

APPLICATION GUIDELINES

In order to obtain the best efficiency in the application of Mapei Active Sil-2, it is recommended to add the product directly to the bitumen tank and mixed with the binder, or during the production of the asphalt mixture by adding it to the bitumen before mixing with the aggregate. If Mapei Active SIL-2 is added to the bitumen tank and needs to be left for an extended period of time, the bitumen should be periodically stirred (by stirring or pumping - circulating). When Active-Sil 2 is added to a tank of hot bitumen, the product retains its properties at temperatures up to 170 degrees Celsius for about 14 days.

DOSAGE

The additive quantity should be determined in accordance with the technical specification, taking into account the operating conditions of the pavement and optimized by prior laboratory testing. Commonly **Mapei Active**



Sil-2 used dosages range from 0.03% to 0.15% by weight of bitumen, depending on the situation (type of aggregate, type of asphalt mixture, layer, etc.).

PACKAGING

- 25 kg tanks
- 215 kg drums
- 1100 kg tanks (IBC containers)

STORAGE

In order to ensure the best storage conditions of Mapei Active Sil-2, the product should not come into contact with water or moisture, it should be stored in its original packaging for up to 12 months, away from heat sources and direct exposure to sunlight at a temperature between 5°C and 40°C.
